


Figure 1 Roadmaps 20 years TEI

Speakers Biography



Dr. Cielito Habito: Chief of Party, USAID Trade-Related Assistance for Development (TRADE) Project at Deloitte Consulting.

Expertise and experience: He has been

working on economic and environment for more than 38 years. He was former Minister for Socio-economic Planning and Chair of the Philippine Council for Sustainable Development. He has held directorships in many government organizations and he has held board directorships in several private corporations. He was Professor and Chairman of the Department of Economics at the University of the Philippines-Los Baños (UPLB).

Panel discussion: He will give opinion on economic potential of ASEAN to compete inside and outside ASEAN market. He will also talk about preparation of ASEAN for advantages and disadvantages of AEC and comparison of AEC to EU and U.S. market. Finally, he will give information of how Philippines prepare for AEC.



Mr. Anbumozhi Venkatachalam: A Fellow and Capacity Building Specialist at Asian Development Bank Institute (ADBI).

Expertise and experience: His expertise is

environment stragegy. He was a distinguished fellow of Asia Pacific Rim University (APRU) Forum on Development and Environment, he also advised JICA, JBIC, UNESCAP projects on sustainable development.

Panel discussion: He will analyze AEC in the view of researcher and how to link Green Supply Chain and Green Product to business in AEC. He will talk about direction of research to support Green Growth and economic potential in AEC. He will give information about fund to support sustainable development of business in AEC.



Mr. Rae Kwon Chung: Director for Environment and Sustainable Development Division at UNESCAPE, Bangkok.

Experise and experience: He is promoting a new

He has been involved in international environment negotiations for climate change and Rio Earth Summit in 1992. He contributed as a lead author for an IPCC special report on technology transfer and received a personal copy of 2007 Nobel Peace Prize as contributor to the award of IPCC Nobel Peace Prize 2007.

Panel discussion: He will analyze environmental impact from the growing of business in AEC and approach for Green Growth and sustainable development. He will give information about policy of UNESCAP on AEC of ASEAN countries for sustainable development.

Ms.Karen Trzcinski: Senior Director, Asia Pacific EH&S Operations
