#### (3) Establish Relationship between Members

Continuity Plan

**Resolution:** All members acknowledged the progress reports.

#### **Comments and Suggestions**

- 1) Mr. Pramote Inswarng/ advisor to TBCSD, asked about implementations of Carbon Credit from September to November 2014. The implementations were interrupted. He asked "what caused interruption?" and were there any obstacles then? He would like the Secretariat Office to clarify these?
- Dr. Qwanruedee/ TEI explained about operations of Carbon Reduction that at present, TGO is a key implementer so we were afraid that the operations would be duplicated. We shifted TBCSD into the Community Carbon Credit operation in Mae Hong Son which is now making progress time to time i.e. delivery of solar panels to communities, installation of solar home, building a small-scale hydrological power plant, etc.
- 2) Mr. Prasert/ Chairman asked whether "the Manifesto" has been terminated operating or not?
- Dr. Qwanruedee/ TEI described that "the Manifesto" has remained operating but "the VA Project" of Department of Alternative Energy Development and Efficiency (DEDE) under "the Manifesto" has been terminated already.

#### 3.1.2 Progress of Special Projects

#### **Low Carbon Society**

#### (1) Green SIEP: The Sirindhorn International Environmental Park

■ In collaboration with RATCH, to organize the activity "Seniors take Juniors to Explore and Study the Ecological System" by planting 300 trees in the area behind the Energy Centre and liberating animals back to the nature at the Sirindhorn International Environmental Park, Phetchaburi Province

## (2) Development of the Community Power Plant in Mae Hong Son Province

• A press conference "the Community Carbon Credit and Mutual Benefit Promotion Project" and Certificate Awarding Ceremony for the Community Carbon Credit for 2 supporters who provided support for the Community Solar Energy Promotion Project in Mae

Hong Son Province, namely, Pandora Production Company Limited and the Ratchaburi Electricity Generating Holding Public Company Limited.

- Ratchaburi Electricity Generating Holding Public Company Limited has already installed solar panels in 25 households at Ban Hua Ha Community, Khun Yuam District, Mae Hong Son Province and the solar lanterns were provided to 25 households at Ban Huay Pou Ling in Mae Hong Son Province. It is currently in process of official delivery ceremony on January 11-13, 2015
- To coordinate and monitor the activities of the pilot areas at Ban Hua Ha and Ban Pa Yoi in Mae Hong Son Province from 27-29 November 2014.

#### (3) Bang Kachao

- Bang Kachao Area is characterized as pig stomach by having Chao Phraya River surrounded in Prapadang District, Samutprakarn Province, consisting of 6 sub-districts which are Songkanong, Bang Kasob, Bang Yor, Bang Numpueng, Bang Kor Bua and Bang Kachao. In order to preserve Bang Kachao Green Space to become the Natural Learning Centre concretely and the communities in the area remain conserving the local way of life sustainably, the initial consultation meeting was conducted to design a project framework on December 24, 2014, including appointing "the Bang Kachao Conservation Project Council for 6 pig stomach districts" to conduct the project, by having Professor Dr. Sanit Aksornkeaw as President and Dr. Qwanruedee Chotichanathawewong as Working Group and Secretariat.
- The 1/2014 The Working Group Meeting was arranged on November 18, 2014 to consider the composition and responsibilities of the committee.
- The 2/2014 The Working Group Meeting was arranged on December 23, 2014 to consider the composition and work plan for next year.

#### **Water Resource Management**

#### Potable Water for Drought-Prone Villages

- A field visits to process of testing samples of ground water of Ban Tung Sawang Samakki Community, Ban Kueng Sub-district, Chiangkwan District, Roi Ed Province by developing the principle of Reverse Osmosis (RO) to improve the quality of water to be potable with 20 participants from 2 organisations (PTT/SCCC)
- PTTGC donated 4 water containers with 2,000 liters containing capacity to be installed instead of the old one that deteriorated already.
- In the process of planning for conducting the activities and discussed action plans for next year

**Resolution:** All members acknowledged the progress reports.

#### **Comments and Suggestions**

- 1) Mr. Pramote/ Advisor commented on the Water Resource Management Project that giving stuff to people should select good and quality materials for example stainless and for long term.
- Mr. Prasert/ Chairman explained that water has saltiness so we selected a material that is well made of plastic and durable.

#### **Comments and Suggestions**

- 1) Mr.Pramote/ Advisor asked about a budget cut of the remaining fund at the end of the year and being carried over into the next year.
- Dr.Qwanruedee/ TEI said that for the 2014 budget, we have 1,650,516 baht left at the moment and this is supposed to be carried over into the year 2015 1,000,000 baht. The remaining 650,516 baht will be allocated to be used in the last 2 months of 2014. If at the end of 2014, this budget still remains, it will be carried over into the year 2015 as well.
- Mr. Pramote/ Advisor suggested that whatever amount is left, the real figures should be shown as such in case of carrying over into the next year so that members will realise the real figures.
