7. Other Business

Resolved: Motion carried, other matters acknowledged, and comments and suggestions to be responded by the secretariat.

7.1 TBCSD Representation at regional/national meetings on quality of growth and climate change

- Mr. Prasert Bunsumpun, Chairman of TBCSD, was invited by the Office of the National Economic and Social Development Board (NESDB) to serve as an advisor to the National Strategic Sub-Committee on Environmental-Friendly Development and Growth.
- Dr. Songkiet Tansamrit, TBCSD advisor, presented in a meeting of the Sub-committee on Climate Change Public Relations and Action for Climate Empowerment held on 19 September 2017 at the Department of Environmental Quality Promotion (DEQP). The meeting was chaired by the Permanent Secretary of MoNRE acting as the Director-General of DEQP.
- Dr. Ampai Harakunarak, Executive Director of TBCSD, represented the TBCSD Chairman to participate in an Asia Pacific Climate Week panel on “Long-lasting Public-Private Partnerships: What is the Secret?” held at the United Nations Conference Center (UNCC) on 14 December 2017.

7.2 Comments and Suggestions to be responded by the Secretariat

- Mr. Pramote/Advisor recommended that:
 - Presentation on progress and achievement of green label and certificates (Programme 1 Sustainable Movement) should describe changes or movements in facts and figures over a period of time, with trend analyzed;
 - TBCSD’s projects and activities should be designed to engage all members and published widely;
 - TBCSD budget should be expanded through resource mobilization to increase project/activity implementation;

- Report to TBCSD Council meeting should specify whether projects are new or ongoing; and,
- Meetings of Council-Associates should be held every quarter of a year (February, April, August, and December) instead of twice a year (March and December). The next meeting in February should be held to consider of TBCSD project plans and activities including operating budget.
- Ms. Natnarin/AIS suggested that TBCSD should create more activities covering all issues, as well as sharing of WBCSD knowledge to TBCSD members.
- Mrs. Poranee/DOW suggested that:
 - TBCSD members should have more opportunities to be engaged in joint projects/activities;
 - Progress and results of TBCSD projects/activities/events should be widely distributed to increase and maintain interest of the public; and,
 - TBCSD should perform leadership role in implementing and promoting SDGs, as well as collaborate with its members to aggregate progress/result and publish on behalf of TBCSD.
- Mr. Payont/GPSC recommended that TBCSD should undertake assessment of benefits and advantages of products being certified by green label which would help promote green (e-co) label schemes.
- Mrs. Warawan/PTTGC suggested that to increase value to plastic waste, an effective management project must be implemented. For instant, PTTGC has implemented Upcycling the Oceans, Thailand project, which is a collaboration project between PTTGC, Tourism Authority of Thailand and Ecoalf Foundation, Spain. The main objective of this project is to collect plastic waste, such as PET, and turn into fashionable goods, such as bags and garments. The project was launched at the Same Island in 2017, which was the pilot area. 10 tonnes of plastic waste were collected and they are now ready to be processed into fashionable goods, which should be available in 2018. Additionally, PTTGC is considering opportunities to manage other type of plastic waste, e.g plastic bags.
- Mr. Santi/Thaioil suggested that TBCSD should create a 3–5 year plan as a strategy for ensuring significant long-term success.
- Dr. Ampai/TEI suggested that TBCSD should consider working with various partners to expand green label scheme in Thailand, mobilize financial resources for climate financing through Green Climate Fund, and address Sustainable Consumption and Production, solid waste management particularly plastic waste in the marine environment, natural disaster, biodiversity and ecology, and development of SDG indicators for TBCSD members.

- Mr. Prasert Bunsumpun/ Chairman tasked the secretariat to prepare and report in the next meeting a plan on TBCSD's broader action in short and long terms, as well as to present financial statement for the year ended 31 December 2017.

8. Chairman's Concluding Remarks

Chairman expressed his appreciation to TBCSD members for their support and participation in the projects and activities in this year while looking forward to continued cooperation among Thai business in fostering sustainable economic growth in combination with sound environmental management throughout 2018 and beyond.
