# Objective of this meeting

 To collaboratively explore and identify actionable approaches to support bottom-up and inform decision-making and planning processes in urban development, climate actions and disaster preparedness





### Background

- One of the key governance challenges in Thailand is inclusive participation in policy and planning processes
  - Too much top-down, little or no bottom-up planning and implementation
- Urgent need to promote and support the civil society to play a critical role in driving urbanisation, climate actions and disaster preparedness
- Need to address urgent and emerging issues of social vulnerabilities and inequalities of marginalised community groups, such as the urban poor, women, disability

#### Project outcomes (Nov2019-Oct2024)

- Strengthening urban governance mechanisms and practices
- CSOs to play a critical role in driving inclusive and equitable urban planning and climate actions
- Building evidence-based knowledge to inform decisions and planning
- Tools and sets of indicators for climate actions available and applicable to local context
- Transformation of urban development towards inclusive, equitable, climate resilient and sustainable urban futures







### Project progress and plans

- Project Year 1 (Nov 2019 Oct 2020)
  - Introduction and invitation of CSOs and local multi-stakeholders to participate in the project
  - Capacity building, training activities for CSOs
  - Shared Learning Dialogues
  - Regional platforms





#### Project progress and plans

- Project Year 2 (Nov 2020 Oct 2021)
  - Vulnerability Assessments
    - Understanding social vulnerabilities in the context of urbanisation and climate change, using people-centred approaches
    - Understanding differential impacts of urbanisation and water-related climate impacts – gender, community groups (e.g. urban poor, marginalised groups)
    - CSOs capacity building practical research training
    - Community-based information, data and evidence-based knowledge to inform decisions and planning
    - Practical tools and indicators applicable to the local / regional context

- Project Year 3
  - Participatory development of urban resilience strategies and community-based climate action plans (based on vulnerability assessments)
  - Development of intervention projects (based on the strategies)
- Project Year 4

  - Refining, integration and mainstreaming of urban resilience strategies and community-based climate action plans
